executive hangars and all tie downs in the area eviction notices. Most of the planes tied down near us have moved to the East ramp, as has Concord Flying Club and most of the executive hangar tenants. For the larger dinners (Christmas and the Crab feed) we can use the terminal building. The cost of the space is just about what we pay now, so the financial impact of a move should be minimal.

So what happened to renting back from ADG? During last minute discussions with Keith it became apparent that ADG does not want to rent back to anyone!! They just want to move right ahead with the development and did not want to bother with tenants. My question is why haven't they signed the lease the Board of Sups approved?

The Board of MDPA wants your opinion as to whether we should move to the Budget building or exist as the club did years ago with no clubhouse? You know what MDPA is like with a clubhouse so I won't go into that. What will we be without a clubhouse? Well, we could hold meetings at the water district offices. We could even hold some potluck dinners there. We could do the same thing at the old terminal building. We could have dinners at Crown Plaza. Financially there are major differences. With a clubhouse our dues will stay the same. If we go without a clubhouse then our dues should decrease. If we move to the Budget building I suspect we will get some additional members due to the proximity of all those planes tied down next to Budget.
