Activities

Scott Davis briefed on the planned fly-out to the Concord Tower.

SAFETY FORUM

Keith Freitas introduced the new Concord ATCT Manager Bob Convery. Bob made a safety presentation regarding near accident at SFO between two commercial aircraft and the importance of read back communications. Bob has worked the past 20 plus years at Oakland Center in Fremont and Livermore Airport.

Tower Manager Bob Convery spoke about the conditions in which the tower would be non-operational (ATC zero) during normal business hours. He explained that this was a less-than-ideal situation but that it was necessary in the interest of safety due to fatigue mitigation for the controllers. He also said that they are working on limiting these outages by schedule adjustments and would do everything we could to minimize such occurrences.

Bob then chronicled the FAA's top 5 safety issues and highlighted one in particular. He

explained that wrong-surface landings and runway incursions were on the rise and that it was a major safety concern at all airports but especially here at CCR. There had been 8 incursions for the previous 12 month period; 1 vehicle, 1 unauthorized departure and 6 with aircraft crossing the hold-short bars. Two of which were by the same aircraft.

He then showed a video that showed a commercial airliner almost taxi on to a runway (SFO) that was being used by a B777 on its takeoff roll. This was to illustrate that lapses in awareness can happen anywhere at any time and we all need to work as a team to reduce and eliminate such situations. He stated we must work together to insure that both pilots and controllers are communicating clearly.
